POLICY REGARDING INTERMENTS & INURNMENTS

- 1. SERVICES:** Tuesday – Thursday, must be in and complete by 3:00 P.M. or an additional charge of \$150.00 per hour will be added and must be completed by 4:00 P.M.
- 2. SERVICES FRIDAY:** Must be in and complete by 2:00 P.M. or an additional charge of \$150.00 per hour will be added and must be completed by 3:00 P.M.
- 3. SERVICES ON SATURDAY:** Are considered special accommodations an \$850.00 added charge is required, and the service completed by 2:00 P.M. **NO SERVICES ARE PERMITTED ON SUNDAY OR MONDAY.**
- 4. FOR SAFETY REASONS, ABSOLUTELY NO WITNESSING OF FULL BURIALS IS ALLOWABLE. HOWEVER THE WITNESSING OF CREMATION BURIALS IS PERMITTED.**
- 5. MARKERS:** All bronze markers must be installed on Granite Bases and all Granite markers must have lawn proof edges. Marker sizes are up to 12x24 for cremation and up to 16x28 for full burial graves. If marker is to cover 2 graves in full burial sections, they can be up to 54x18.
- 6. One vase is permitted in BABY AND CREMATION spaces, However in regular gravesites up to two vases are permitted.**
- 7. DISINTERMENT:** Monday – Friday only depends on depth, type and weight of vault. A mortuary is required and a new permit (cost is at the discretion of the District Board of Directors)
- 8. AT NO TIME IS THE PLACING OF DECORATIVE ARTICLES ALLOWED ON ANY GRAVESITE. NO GLASS CONTAINERS, CROCKERY, STANDING DECORATIONS OF ANY TYPE, ANGELS, PINWHEELS, FENCES, ARTIFICIAL FLOWERS, AND GLASS GLOBES ETC. ONLY FRESH FLOWERS PLACED IN A CEMETERY INSTALLED IN-GROUND FLOWER VASE ARE ALLOWED AT ANY TIME. HOWEVER, AT SPECIAL TIMES DURING THE YEAR, I.E. MOTHER OR FATHERS DAY, CHRISTMAS, MEMORIAL DAY, EASTER ETC., BALOONS, FLAGS OR SPECIAL DECORATIONS MAY BE PLACED FOR A PERIOD NOT TO EXCEED TWO WEEKS, AT WHICH TIME THE ITEMS MAY BE REMOVED AND DISCARDED. PLEASE INFORM ALL FAMILY AND FRIENDS OF THIS INFORMATION.**
- 9. AT NO TIME ARE PETS ALLOWED IN THE CEMETERY UNLESS KEPT IN AN AUTOMOBILE**
- 10. ALL PLANTING IS RESTRICTED EXCLUSIVELY TO MANAGEMENT**
- 11. AT NO TIME ARE ALCOHOLIC BEVERAGES ALLOWED IN THE CEMETERY**
